## TERMS OF SALES

### **Article 1: Registration and booking of surf lessons**

Any registration for a surf lesson or a service in our structure is made from the registration form which must be duly completed by the parents or the legal guardian if it is a minor, or by the person concerned if it is an adult. The payment of the service will be made in cash or check by bank check (compensable only in France), denominated in Euros.

A deposit of 50% of the total amount of the chosen formula will be required to confirm the reservation. The balance will be payable on the first day of the course.

Registration for our courses and / or internships implies acceptance of these rules.

Booked by post, he must send us a letter with the chosen formula and the 50% deposit by bank check (compensable only in France), denominated in Euros, to the following address:

Please note: The amount paid by the customer must correspond exactly to the amount of the deposit requested. He is advised to send a check for an amount strictly equal to the amount of the deposit required (50%).

Any payment greater than the deposit requested cannot be reimbursed for the difference. The reservation is not final until receipt of payment. If the check is not received within the period notified in the preamble to these General Conditions of Sale, the reservation will be automatically canceled without notice. - Golf surf school cannot be held responsible for delays from the Post Office or any other operator, loss of mail, strikes or hazards related to transport.

### **Article 2: Cancellation of surf lessons**

In the event of bad weather conditions (too strong sea, thunderstorm ...), the courses which cannot be carried out within the framework of the subscribed service will, in agreement with the trainees: - Replaced by a substitution activity (discovery of the environment , materials, environmental awareness, courses theories, visit the shape workshop ...)-

Postponed to a later date in the possibility of school schedules and student availability

- Converted into a valid credit card in our surf school (school only)
- Refunded as a last resort (school only)

### **Deposit refund terms**

Any cancellation occurring:

- One month before the service: full refunded deposit
- 15 days before the service: half of the deposit refunded
- Less than 15 days before the service: the deposit will not be refunded
- Lessons not completed because of the student will not be reimbursed.
- A service or internship started and interrupted cannot be reimbursed.

### **Article 3: Responsibility for the structure**

Trainees will be taken care of by the structure and therefore under their responsibility when their names are called. They remain under his responsibility until the storage of their suit. The structure's civil liability for its trainees ceases outside these hours, within the deadlines described above. Parents or persons in charge of the trainees must make sure before entrusting the participants in the structure that the planned service takes place. Participants certify that they have read the school's liability insurance coverages and have been informed about their interest in taking out additional insurance cover in the event of bodily injury occurring during activities organized by the surf school (law of 1984 as amended). Participants are responsible for the equipment entrusted to them (boards, coveralls, etc.) during class hours and in particular in the event of loss, theft or damage. the surf school declines all responsibility in the event of loss, theft or deterioration of objects which may be entrusted to it.

#### **Article 4: Insurance**

All people enrolled in the Golf Surf School are covered by our Civil Liability and Individual Accident guarantees, the details of which are described in the contract n ° 119.356.931 made available to parents or legal guardians. The school does not offer these guarantees only during teaching hours. However, participants must have complementary health insurance and repatriation assistance insurance. The Golf Surf School provides members with forms allowing them to take out additional insurance

guarantees. Parents or legal guardians may refuse these insurance guarantees if they believe that they are sufficiently covered by their own insurance contract, in accordance with the conditions provided for by sport law. It is understood that the participant or his legal representative acknowledges having been aware of the conditions and amount of guarantees see Appendix for which he acknowledges that he does not need to take out additional cover.

#### **Article 5: Commitment of the structure**

The golf surf school disclaims all responsibility in the event of non-compliance with the instructor's safety instructions. Our structure agrees with its customers not to use defective equipment or asperities which may be dangerous. Our equipment is checked every end of the day.

We are also committed to ensuring that our groups are as homogeneous as possible. Finally, the quality of our teaching and our welcome are very important to us; the golf surf school is committed to providing you with the best in this area.

#### **Article 6: Engagement of students**

By enrolling in the Golf Surf School, minor trainees and their parents accept the risks associated with the practice of Surfing under normal conditions of practice. The trainee declares to be in good health, to know how to swim 25 meters, and to be able to practice surfing.

#### **Article 7: Transport of trainees (in the event of the use of a vehicle as part of the services proposed)**

The Surf School undertakes to ensure the transport of trainees in compliance with the regulations in force:

- drivers holding the necessary license
- vehicle insurance coverage
- compliance with the maximum number of passengers
- clean and undamaged vehicle (obligatory revisions)

By registering, you authorize the golf surf school to use the photos and / or films of your image produced during your internship, for the production of all advertising documents, without any financial compensation.
