TERMS OF SALES

Article 1: Registration and reservation for surf lessons

Any registration for a surf lesson or a service in our structure is made using the registration form which must be duly completed by the parents or legal guardian if it is a minor, or by the person concerned if it is an adult. Payment for the service will be made in cash or by bank check (clearable only in France), denominated in Euros.

A deposit of 50% of the total amount of the chosen package will be requested to validate the reservation. The balance will be due on the first day of the course.

Registration for our courses and/or internships implies acceptance of these regulations.

Reserved via post, you must send us a letter with the chosen formula and the 50% deposit by bank check (compensable only in France), made out in Euros, to the following address: École de surf du golf - 10 places de la Bastide - 40660 Moliets et maâ

Reserve via the internet, make a deposit transfer request from us and send us the registration forms by email surfingolfmoliets@gmail.com

Please note: The amount paid by the customer must correspond exactly to the amount of the deposit requested. He is advised to send a check for an amount strictly equal to the amount of the deposit requested (50%). Any payment greater than the requested deposit will not be subject to reimbursement of the difference. The reservation is only final upon receipt of payment. In the event of non-receipt of the check within the period notified in the preamble to these General Conditions of Sale, the reservation will be automatically canceled without notice. - Golf Surf School cannot be held responsible for delays by the Post Office or any other operator, loss of mail, strikes or hazards linked to transport.

Article 2: Cancellation of surf lessons

In the event of bad weather conditions (too rough seas, storms, etc.), the courses which cannot be carried out as part of the contracted service will be, in agreement with the trainees:

- Replaced by a substitute activity (discovery of the environment, equipment, awareness of ecology, theoretical lessons, shape workshop visit.)
- Postponed to a later date subject to school schedules and student availability - Transformed into a valid credit in our surf school (school only)
- Reimbursed as a last resort (school only)

Deposit reimbursement terms

Any cancellation occurring:

- One month before the service: entire deposit refunded
- 15 days before the service: half of the deposit refunded
- Less than 15 days before the service: the deposit will not be refunded

Lessons not taken due to the student's fault will not be refunded.

A service or course started and interrupted cannot be refunded.

Article 3: Responsibility of the structure

The interns will be supported by the structure and therefore under its responsibility when their name is called. They remain under their responsibility until their suit is put away. The civil liability of the structure concerning its interns ceases outside these hours, within the deadlines described above. The parents or those responsible for the trainees must ensure before entrusting the participants to the structure that the planned service takes place.

Participants attest to having read the civil liability insurance guarantees of school and having been

informed of their interest in taking out additional insurance guarantees in the event of bodily injury occurring during activities organized by the surf school (amended 1984 law). Participants are responsible for the equipment entrusted to them (boards, wetsuits, etc.) during class hours and particularly in the event of loss, theft or damage. the surf school declines all responsibility in the event of loss, theft or damage to objects which may be entrusted to it.

Article 4: Insurance

All people registered at the golf surf school are covered by our Civil Liability and Individual Accident guarantees, the terms of which are described in the contract n° 119.356.931 made available to parents or legal guardians. The school does not offer these

guaranteed only during teaching hours.

However, participants must have additional health insurance and repatriation assistance insurance.

The Golf Surf School provides members with forms allowing them to take out additional insurance guarantees.

Parents or legal guardians may refuse these insurance guarantees if they consider that they are sufficiently covered by their own insurance contract, in accordance with the terms provided for by the sports law.

It is understood that the participant or his legal representative acknowledges having been aware of the conditions and amount of guarantees see Appendix for which he acknowledges not needing to take out additional coverage.

Article 5: Commitment of the structure

The golf surf school disclaims all responsibility in the event of non-compliance with the safety instructions of the instructors.

Our structure undertakes to its customers not to use defective equipment or equipment with rough edges that could be dangerous.

Our equipment is checked every end of the day.

We are also committed to ensuring that our groups are as homogeneous as possible. Finally, the quality of our teaching and our welcome are very important to us; the golf surf school is committed to providing you with the best in this field.

Article 6: Student engagement

By registering at the Golf Surf School, minor trainees and their parents accept the risks linked to the practice of Surfing.

under normal practical conditions.

The trainee declares to be in good health, to know how to swim 25 meters, and to be able to practice surfing.

Article 7: Transport of trainees (in the event of use of a vehicle as part of the services offered)

The Surf School undertakes to ensure the transport of trainees in compliance with current regulations:

- drivers holding the necessary license
- vehicle insurance coverage
- respect for the maximum number of passengers
- vehicle clean and in good condition (revisions required)
